- The cover page should bear only the title of the paper, name/s of author/s, their official address. E-mail ID, phone/fax no., and acknowledgement (if any).
- The first page of manuscript (after the cover page) should contain the title and the abstract only.
- Footnote should be kept to a minimum and be numbered consecutively throughout the text with superscript Arabic numerals.
- Lastly papers which focus on the seminar theme would be given top priority in the selection process.

### Guidelines for Abstract

The Abstract should not exceed 500 words and should include:

- \* Title
- \* Background
- \*Objectives
- \*Methodology
- \*Findings/Results

The Contributor(s) should kindly provide their name/s, affiliation, mailing address, e-mail and phone number along with the abstract.

### Review Process

The manuscript will be subjected to a critical review. The decision of the reviewers will be final and binding in all respect.
