It provides a framework for justice by guaranteeing fundamental rights such as equality before the law, the right to a fair trial, and protection against arbitrary actions of the state.

The judiciary plays a critical role in interpreting constitutional provisions and ensuring that access to justice is not just a theoretical ideal but a practical reality. Apart from the judiciary, other legal institutions, including law enforcement agencies, legal aid organizations, and bar councils, also have significant roles in enhancing access to justice. The Constitution provides the bedrock on which this access is built, while legal institutions ensure that justice is not just a promise on paper but a reality for all citizens.

ABOUT THE SEMINAR

The field of law and equality is of paramount importance as it shapes various aspects of our society, and individual rights. The seminar will focus on enhancing access to justice by analyzing the interplay between the Constitution, which guarantees fundamental rights, and the legal institutions, which serve as the mechanism for the enforcement of these rights. CALL FOR PAPERS

Modern College of Law invites well researched and unpublished research papers, case analysis, and articles by Academicians, Policymakers, Journalist, Lawyers, Bureaucrats, Research scholars and Students. Research papers shall be subject to the approval of the Editorial Board for inclusion in the seminar. The Seminar calls for papers under the following sub-themes. Note- The above mentioned sub themes are prescriptive and author(s) can write papers on any topic within the scope of the main theme or related to the above mentioned sub themes.

SUBMISSION GUIDELINES

- ▶ All submissions have to be in English language.
- ▶ The abstract should not be more than 500 words. It shall be accompanied by a cover letter containing - a brief profile of the author including e-mail ID, contact number, designation, institution and official address & details of Co-authors (if any).
- ▶ There can be a maximum of only one Co-Author. All the co-authors need to get registered for the seminar.
- ▶ The word limit for a research paper is 6000-8000 words (Inclusive of all citations and references).
- ▶ Submissions must be typed in Times New Roman, Font Size 12 on A4 size paper with 1" margin on all sides with 1.5-line spacing. The heading should be in Times New Roman, Font Size 14, Bold, 1.5-line spacing, center-aligned while sub-heading should be in Times New Roman, Font Size 13, Italicized, 1.15-line spacing. Footnotes must be in Times New Roman, Font Size 10 with 1.0-line spacing. The file extension shall be .doc only.
- ▶ Plagiarism shall not exceed more than 10%.
- ▶ The Author(s) should also send a declaration along with the abstract & final paper that their work is original and unpublished and that it does not infringe the copyright laws. The organizing committee is not responsible for any copyright infringements by the authors and if found the paper is liable to be disqualified at any stage.
- ▶ Author (s) are required to adhere to a uniform mode of creation 21st edition of The Bluebook A Uniform System of Citation.
- ▶ Author(s) who intend to present their research papers in the seminar are required to submit the abstract on or before DATE-: 31st October 2024 (latest by 11:59 PM) through the provided link.
- ▶ The abstracts will be blind peer-reviewed by the Editorial Board and only short-listed abstracts will be invited to submit final papers as well to present them in National Seminar. The final paper should be submitted after the intimation of acceptance of the abstract.
